
66 Elm Street Camden, ME Valuation: How is the sale/purchase price to be figured?

- Market
- Appraised Value
- Assessed Value
- Discount: Should the selling interest price be discounted?
- Discount if selling to brother or sister
- Discount if selling to cousin
- · Discount if selling to other

Rights of First Refusal: If someone can sell their interest, must they first offer it to existing interest-holders?

Paying for It

- Proportionally by interest users pay their fair share of carrying costs

Passing on the Family Camp Planner


